### **RÉMI BOYER IS APPOINTED KORIAN'S GROUP HUMAN RESOURCES DIRECTOR**

In 2013, he became Group VP R&D HR and Support, before being appointed as VP Talents and Top Management of PSA Peugeot Citroën Group in 2015.

Graduate of *Ecole Normale Supérieure*, holder of a French History *Agrégation* and a Master's Degree of International Relations, Rémi BOYER spent the majority of his career in industrial companies.

Rémi BOYER has taken up his position on the 1st of September 2016.
